



1, OUT OF BOUNDS (Rule 2.1 and 18).

- a) Marked by any white post, fence, wall or ditch bounding the course.
- b) 2nd, 7th, 8th and 11th holes, any ball that crosses the old railway line even though it may remain on another part of the course.

2, PENALTY AREAS (Rule 17).

All penalty areas at Styrrup Hall Golf Club are Red penalty areas and are marked by red posts. The player may either play the ball as it lies or take penalty relief in accordance with the appropriate specific rule for one penalty stroke.

3, OVERHEAD POWER CABLES (Rule 14.6).

A ball striking an overhead power line within the boundary of the course MUST be replayed without penalty using either rule 14.6a or 14.6b.

4, ABNORMAL COURSE CONDITIONS – (Including Immoveable Obstructions) (Rule 16)

- 4.1 Electricity poles and stanchions, fixed sprinkler heads, steps in bunkers and bins, “all identified paths”. Free relief to be taken in accordance with Rule 16.1a or 16.1b.
- 4.2 Refer to the item 11 for a definition of “identified paths”.
- 4.3 Relief for interference on the line of play is given where a ball is on or within two club lengths of a fixed sprinkler head which is also within two club lengths of the green. The player may take relief under rule 16.1b.
- 4.4 If a player’s ball lying on a Putting Green is in or touches an artificial hole plug, or if the hole plug intervenes on the line of play, the player may take relief under Rule 16.1d. Relief is not available if the hole plug only interferes with the player’s stance.

5, NO PLAY ZONE (Rule 2.4).

A no play zone is a defined part of an abnormal course condition (see rule 16.1f) or a penalty area (see rule 17.1e) where play is not allowed. A player must take relief when their ball is in a no play zone, or a no play zone interferes with their area of intended stance or area of intended swing in playing a ball outside the no play zone see rules 16.1f and 17.1e)

- a), Ground Under Repair is any area defined by a white line or marked with a GUR sign. Free relief MUST be taken as described in Rule 16.1b.
- b), All staked trees and any unstaked saplings less than 6ft tall. Relief MUST be taken under Rule 16.1f.

6, WRONG PUTTING GREEN (Rule 13.1f).

Complete relief MUST be taken if a ball is on or there is interference for intended stance and intended swing by a wrong putting green.

7, STARTING HOLE.

Unless otherwise advised by the Handicap and Competitions committee all competitions and General play cards which will be used for handicap purposes must start from the first hole. The 10th hole cannot be used as a “starting” hole. The exception to this rule is a shotgun start.

8, GENERAL.

- These full Local Rules are also posted on the club web site and the club notice board.
- Temporary Local Rules will be posted within the Pro Shop.
- The short form of the Local Rules printed on Scorecards includes the following rules: 2, 3 (except list of paths and 3.3 and 3.4), 4, 7 (2nd para) and 8.

9, PERSONAL RIDE ON BUGGIES.

Personal ride-on buggies are permitted subject to having sufficient insurance for use on:-
a) the course.

b) off the course i.e. (Our carpark). We require either a copy of your insurance certificate or a written confirmation from your insurance that clearly states buggies and use of them. For you to bring and use your buggies on our course we will need to have the above mentioned on file.

10, NON-PLAYING CHILDREN UNDER 10 YEARS OLD.

Non-playing children under 10 years old are not allowed to accompany players.

11, IDENTIFIED PATHS.

The following paths are where free relief can be taken in accordance with Rule 16.1b:-

- 1, The path between the White/Yellow/Red Tee boxes on the 1st Hole to the front end (North) of the Red Tee box.
- 2, The path at the right side (North) of the 2nd Hole going up to the old railway crossing.
- 3, The path to the right and rear (Northeast) of the 3rd White Tee box.
- 4, The path at the right-hand side (Northeast) of 3rd green and fairway going towards the 4th Tee box
- 5, The path to the right side (Southwest) of the 4th White/Yellow Tee Box.
- 6, The paths to the rear of the 4th Green towards the 5th Tee boxes.
- 7, The path to the left side (South) of the 7th Tee boxes for the length of the 7th Tee boxes.
- 8, The path to the right side (North) of the 8th White/Yellow Tee Box for the length of the White/Yellow Tee box.
- 9, The path to the left of the 9th green (Northeast) leading to the walkway through the woods to the 10th Tee.
- 10, The path to the right side (Southeast) of the 10th Tee Box going up to the old Railway crossing.
- 11, The path to the right-hand side (North) of the 11th White/Yellow Tee box up to the back (East) of the Red Tee Box.
- 12, The path from the 11th fairway which leads to the path at the side of the 12th Tee Boxes.
- 13, The path at the right side (Northeast) of the 12th White/Yellow Tee Box.
- 14, The path at the left-hand side (Northeast) of the 13th Yellow Tee box for the length of the Yellow Tee box.
- 15, The path at the rear (North) of the 13th Green together with the path at the left of the 13th Green which leads to the 14th Tee.
- 16, The Path at the right side (Southeast) of the 14th Tee Box for the length of the Tee box.
- 17, The public footpath at the bridge on left-hand side (Northwest) in front of the 14th Tee box.
- 18, The public footpath at the rear (Southwest) of the 16th Green.
- 19, The Path at the Left-hand side (Northeast) of the 17th White/Yellow Tee Box.
- 20, The Path at the left (North) of the 17th Green leading towards the 18th Tee boxes.
- 21, The Path to the right-hand side (Southwest) of the 18th White/Yellow Tee box.
- 22, The Path to the left (Southeast) of the 18th Green heading up to the pro shop area. (If not out of bounds.)
- 23, Paths on all bridges going across the fairways of the 6th and 9th holes including mats before and after the bridges.

Note: Tractor paths are NOT free relief unless marked GUR by the Greens staff. This means for example areas down the left of the 3rd (Southwest) and 7th (South) holes are not areas for free relief unless marked. The same applies for tractor wheel marks (not free relief) unless Marked GUR.

12, PENALTY FOR BREACH OF LOCAL RULES

IN STROKE PLAY – GENERAL PENALTY (2 strokes). MATCH PLAY- LOSS OF HOLE.
